7. NEW BUSINESS

- A. January review & COVID contingencies
 - a. Continue as is until we have to turn people away.
 - b. Make it known that the contemporary service is popular but that the traditional services is often available.
- B. Briercrest Courses
 - a. Pastor Kelvin Kehler
 - i. Goal is to obtain a masters of counselling, which would be beneficial both working with youth and with the church as a whole.
 - ii. Two courses already completed.
 - iii. Two courses offered at present: Pastoral Counselling and Old Testament Survey. Pastor Kelvin Kehler would prefer taking the pastoral Counselling course.

iv. **Motion** to grant permission for Pastor Kelvin Kehler to sign up for the Pastoral Counselling course and for EFC to share in the cost of the course. Terry Neumann **motioned**. Paul Budinski **seconded**. **Carried**.

b. Pastor Jesse Kane

- i. Interested in obtaining Leadership Certification: Change Management
 - 1. 5 classes are required to get the certificate.
 - 2. Interested in joining the April class.
- ii. Would contribute to a masters of divinity
- iii. **Motion** to grant permission for Pastor Jesse Kane to sign up for the leadership certificate and for EFC to pay for \$700 of the cost of the course. Paul Budinski **motioned**. Mike Ettrich **seconded**. **Carried**.

c. ECCC

- i. Courses offered by ECCC are independent of schooling that Pastors Kelvin and Jesse are pursuing.
- ii. Orientation classes will be required to be taken by the pastors at EFC after membership is approved.
- iii. Timeline of required courses is approximately 3 years.

C. Nomination Committee Update

- a. No one new has come forward to be part of the nominating committee yet.
- b. Sonya MacQueen still considering. Pastor Josh Mueller will still approach Adrian Wanke, Melissa Wood, and Cynthia Lazarenko.
- c. By the spring meeting, we should have an idea of any new council members who are willing to have their name stand.
 - i. Paul hopes to get a teaching position in Edmonton after his Master's, in which case he will be able to stay on the council.
 - ii. The usual term to serve on council is two years. A council member may then serve for another 2 years before 1 year is mandated off.
